## NM PreK Required Monthly Enrollment Report

The NM PreK Required Monthly Enrollment Report accounts for current PreK enrollment. This report is due the first week of each month. This is the actual current enrollment number.

**The table below needs to include the Classroom Name exactly how it is seen in EPICS/STARS**

**To calculate the percentage (%):**

Take the actual enrollment (15) / total funded enrollment (20) = .75 x 100 = 75%
