 The site is a React application that leverages the Next.js framework, hosted in the cloud. All coding is done in js/jsx for the application.
- 4. What database and data warehouse solutions are currently used (SQL Server, Oracle, Postgres, etc.)?
 - There is no database solution. The application uses Static Site Generation (SSG) to create the pages when deployed using JSON source data files.

 - Districts and charter school annually provide any updates/changes to the current data represented in the dashboard through the instructional material annual report (Google Sheets) process. This is completed annually in the fall.

 - There are about 193 districts and charter schools, each provide data for English language arts, math, and science for grades K-5, 6-8, and 9-12. That is 7,527 rows of spreadsheets or more. We plan to add expenditure and revenue data for each district and charter school over the course of a six-year cycle which could be 12 data points for each.
